This is in reference to your request for an amendment of the **Community Noise Permit No. O 22-087; Interstate Route H1 & H2 Destination Sign Upgrade/Replacement, Phase 3 along Interstate H1 & H2, Oahu.**

The Community Noise Permit restrictions has been modified to:

USE OF THE CONCRETE SAW, JACKHAMMER, HOERAM, PAVEMENT SCARIFIER, IMPACT DRIVERS, IMPACT WRENCHES, RIVETBUSTERS, & CHIPPING GUNS SHALL BE LIMITED TO 9:00 A.M. TO 6:00 P.M., MONDAY THROUGH SATURDAY. THE CONTRACTOR SHALL NOTIFY THE SURROUNDING PROPERTIES PRIOR TO HOERAM ACTIVITIES.

Should the Department of Health receive any complaints, the Department may impose additional restrictions or possible suspension of the Community Noise Permit.
