The following amendments shall be made to the Bid Documents:

#### A. PRE-BID CONFERENECES

Additional pre-bid conferences were held on November 13, 2012 at 8:30 A.M. and on November 16, 2012 at 2:00 P.M. The attached pre-bid conference minutes, including the list of attendees, shall be incorporated and made a part of the Bid Documents.

#### B. RESPONSE TO QUESTIONS FROM THE PRE-BID CONFERENCE

The following responses are provided to unanswered questions from the pre-bid conference held on November 16, 2012.

1. Question: How will the Contractors get access to the work site?

Answer:

Contractor's will only be allowed to access the project site from Pilina Way, the state-owned portion of Po'okela Street and Area 1 along the privately-owned portion of Po'okela Street. A construction and maintenance access gate is located at the cul-de-sac of Pilina Way, and near the intersection of Po'okela Street and Kupohu Street. See Plan Sheet ADD.10, dated 10/29/12, for the location of the project site, Pilina Way, Po'okela Street, Area 1 along Po'okela Street, and the construction and maintenance access gates.

The Contractor will not be allowed to access the project site from any portion of Kupohu Street. See notes pertaining to Access Restriction for Private Roadways on Plan Sheet 4.

2. Question:

Will there be any restrictions due to the wetlands?

Answer:

See various permits and permit conditions for restrictions due to wetlands at the project site. The scanned images of the various permits, permit conditions and other documents are included on original bid DVD.

3. Question:

Can we get a disk with all the addendums for the project?

Answer:

Yes. A DVD containing all bid documents will be available at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Honolulu, Hawaii 96813.

4. Question:

Is there a soils report for the project?

Answer:

Yes. The scanned image of the geotechnical engineering exploration report for the project is included on the original bid DVD.
