Bids received after the established due date and time will not be considered.

The project includes cold planing, reconstructing existing pavement by removing portland cement concrete and replacing with asphalt concrete, and installing pavement markings. Estimated construction cost is between \$300,000 and \$500,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of bidding.

The Hawaii Products Preference pursuant to ACT 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a

Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO Form 38) to the Department of Transportation Contracts Office no later than 4:30 p.m., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the Department.
