WITNESSETH: That for and in consideration of the payments hereinafter mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to complete in place, furnish and pay for all labor and materials necessary for "FORT WEAVER ROAD WIDENING NEAR LAULAUNUI STREET, OAHU, FEDERAL-AID PROJECT NO. CMAQ-076-1(8)", or such a part thereof as shall be required by the STATE, the total amount of which labor, material and construction shall be computed at the unit and/or lump sum prices set forth in the attached proposal schedule and shall be the sum of ____SIX MILLION THIRTY THOUSAND EIGHT HUNDRED TWENTY NINE _____AND 30/100____ DOLLARS (__\$6,030,829.30___) as follows:

which sum shall be provided from the following funds:

all in accordance with the specifications, the special provisions, if any, the notice to bidders, the instructions to bidders, the proposal and plans for <u>Federal-Aid Project No.</u>

Transportation. These documents, together with all alterations, amendments, and additions thereto and deductions therefrom, are attached hereto or incorporated herein by reference and made a part of this contract.

The CONTRACTOR hereby covenants and agrees to complete such construction within <u>TWO HUNDRED FIFTY</u> WORKING days from the date indicated in the notice to proceed from the STATE subject, however, to such extensions as may be provided for under the specifications.

Where Federal funds are involved, it is covenanted and agreed by and between the parties hereto that the sum of FOUR MILLION EIGHT HUNDRED TWENTY FOUR THOUSAND FORTY TWO AND 83/100 DOLLARS (\$4,824,042.83) and TWO HUNDRED FORTY ONE THOUSAND TWO HUNDRED TWO AND 57/100 DOLLARS (\$241,202.57), a portion of the contract price and extras, respectively, shall be paid out of the applicable Federal funds, and that this contract shall be construed to be an agreement to pay said sums to the Contractor only out of the aforesaid Federal funds if and when such Federal funds shall be received from the Federal Government, and that this contract shall not be construed to be a general agreement to pay said portions at all events out of any funds other than those which may be so received from the Federal Government; provided, that if the Federal share of the cost of the project is not immediately forthcoming from the Federal Government, the STATE may advance the CONTRACTOR the anticipated Federal reimbursement of the cost of the completed portions of the work from funds which have been appropriated by the STATE for its pro rata share.

The CONTRACTOR further agrees to execute the attached non-gratuity affidavit form prior to payment of the final payment by the STATE.

All words used herein in the singular shall extend to and include the plural. All words used in the plural shall extend to and include the singular. The use of any gender shall extend to and include all genders.
