**The project includes clearing and grubbing; demolishing, removing, and disposing of existing structures; disconnecting, removing and/or capping all utilities and piping; mass grading of demolished structures; installing temporary traffic control; and controlling rodents and dust.** Estimated construction cost is between \$25,000 and \$75,000.00.

To be eligible to award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or General Building Contractor's "B" license or Specialty Contractor's "C-24" licenses, prior to the award of the contract.

A pre-bid conference is set for 10:00 A.M., April 8, 2011, at the Department of Transportation, Highways Division, 601 Kamokila Boulevard, Room 609, Kapolei, Hawaii. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory.

The Equal Employment Opportunity Regulations of the Secretary of Labor implementing Executive Order 11246, as amended shall be complied with on this project.


