Bids received after the established due date and time will not be considered.

**The project includes cold planing, resurfacing, reconstruction of weakened pavement areas, replacing existing asphalt concrete pavement with reinforced concrete slab to span over the existing damaged culvert, constructing new bridge approach slabs, installation of new guardrails, milled centerline and shoulder rumble strips, striping, pavement markings, and signage, upgrading existing guardrails, end treatments, bridge rails, construct curb below existing guardrail thrie beam, reconstruction of a**

**culvert headwall and top portions of drainage inlets, and adjustment of utility manholes.** Estimated construction cost is over \$15,000,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license prior to the award of the contract.
