THIS AGREEMENT, made this 29th day of March, 2004, by and between the STATE OF HAWAII, by its Director of Transportation, hereinafter referred to as "STATE", and JAS. W. GLOVER, LTD., a Hawaii corporation, whose business and/or mailing address is P. O. Box 579, Honolulu, Hawaii 96809, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments hereinafter mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to complete in place, furnish and pay for all labor and materials necessary for "FARRINGTON HIGHWAY SAFETY IMPROVEMENTS, NANAKULI TO MAKAHA, DISTRICT OF WAIANAE, ISLAND OF OAHU, FEDERAL AID PROJECT NO. STP-093-1(18)", or such a part thereof as shall be required by the STATE, the total amount of which labor, material and construction shall be computed at the unit and/or lump sum prices set forth in the attached proposal schedule and shall be the sum of SEVEN MILLION ONE HUNDRED

NINETY THREE THOUSAND AND NO/100------DOLLARS (\$7,193,000.00) as follows:

STP-093-1(18)</u> on file in the office of the Director of Transportation. These documents, together with all alterations, amendments, additions and deductions thereto or therefrom, are attached hereto and/or incorporated herein by reference and made a part of this contract.

The CONTRACTOR hereby covenants and agrees to complete such construction within THREE HUNDRED FORTY (340) WORKING DAYS subject, however, to such extensions as may be provided for in writing under the specifications.
