Question 5: Has funding been secured?

Response: State and Federal funding has been secured.

Questions 6: Who will provide the typical construction noise and grading permits?

Response: Contractor is responsible for obtaining the typical construction permits.

Question 7: Who is responsible for the After Grading Report?

Response: Contractor is responsible to comply with the requirements for Construction Permits.

Question 8: Will all RFI's be made available to everyone? Response: If response requires an addendum, response/addendum will be made available to all bidders. Question 9: Has the Utility Agreements been completed and paid for? Response: Utility Agreements have been executed and will be paid for according to the agreement.
