

## DEPARTMENT OF PARKS & RECREATION NOTES

- 1. The Project shall not negatively impact the daily operations, scheduled activities, and special events; such as plant sales, evening concerts, and other themed events at Foster Botanical Garden (FBG). To avoid such conflicts, the SDOT shall contact Derrick Miyasaki, Acting Director of the Honolulu Botanical Gardens (HBG), at 522-7060, to coordinate the construction start date for the proposed project.
- The General Contractor and sub-contractor will not be allowed to park personal vehicles, construction vehicles, equipment, stage and/or stockpile materials, and other construction related items at the FBG parking lot and grounds
- 3. Water and electrical hook-ups from FBG will not be made available for the construction and General Contractor (GC) use.
- 4. The pedestrian and vehicular entrances to the FBG visitor parking lot shall remain open and ADA accessible during business hours seven days per week, and for the after-hours events.
- 5. Locate the proposed new traffic signal pole in the sidewalk and not in the FBG ewa side landscaped planter since the landscaped area is at FBG's main entrance.
- 6. In the event that it is determined during the course of the construction work that the proposed traffic signal and new curb ramp will impact the FBG trees, a Qualified Arborist (QA), approved by the Division of Urban Forestry (DUF), shall be hired at no cost to the City to Perform the tree root and branch pruning work. A QA is necessary to protect the City from liability and poor workmanship and must assure that the work performed does not destabilize the trees and cause failure or demise of the trees. Contact the Arboriculture Section of DUF, at 971-7151 for a copy of the Qualified Arborist Application.
- 7. Will the SDOT require a QA to protect the State-owned trees during the narrowing of the Vineyard Boulevard median, demolition, trenching, concrete curbing and roadway paving work? These median trees will require root and branch pruning work, tree care, and watering during construction.
- 8. The plan does not require tree removals. However, during construction, if trees needed to be removed, the preparation and execution of public notification (The Outdoor Circle, neighborhood board) for tree removals and any action necessary to defend and justify the work is the responsibility of SDOT.

- 9. The State of Hawaii Department of Transportation (SDOT) to contact Foster Botanical Garden (FBG) at 522-7060 to schedule a Pre-construction meeting at FBG, to be attended by SDOT Project Engineer, Engineer Consultant, and General Contractor (GC). Discussion to include, but shall not be limited to, the proposed construction timeline, impacts to FBG scheduled activities and events, tree protection mitigation methods, tree protection zone fencing alignment to protect trees, shrubs, grass and grounds from construction damage, potential tree root and branch pruning work, equipment and vehicle set-up and clearance concerns. The GC and his subcontractors are not allowed to park personal vehicles, construction vehicles, equipment, stage and/or stock pile materials and other construction related items in the FBG parking lot and grounds. Water and electrical hook-ups will not be allowed for GC usage.
- 10. It is recommended that the Tree Protection Zone (TPZ) Fencing layout be staked out in the FMB ewa side landscaped planter by the GC for FBG staff review, modification, and approval at the Pre-construction meeting. The Pre-construction meeting will also determine if other areas in and around FBG will require TPZ Fencing and TPZ Signage.
- 11. GC will be responsible, at no cost to the City and County of Honolulu to restore to their original condition or better areas damaged as a result of the construction work.
