







PARTIAL PLAN AT ABUTMENT SHEL


TYPICAL ABUTMENT SECTION




TYPIICAL COLUMN ELEVATION








TYPICAL PLAN ~ ADDED REINF LAYOUT AT POST TENSION DUCT ANCHORAGE

POST TENSION ANCHORAGE DETAILS





PART ELEVATION - BEAM "P" OVER EXPANSION PIECE




PART ELEVATION - BEAM "E" OVER FIXED PIECE






H-1 INBOUND DECK FRAMING PLAN
