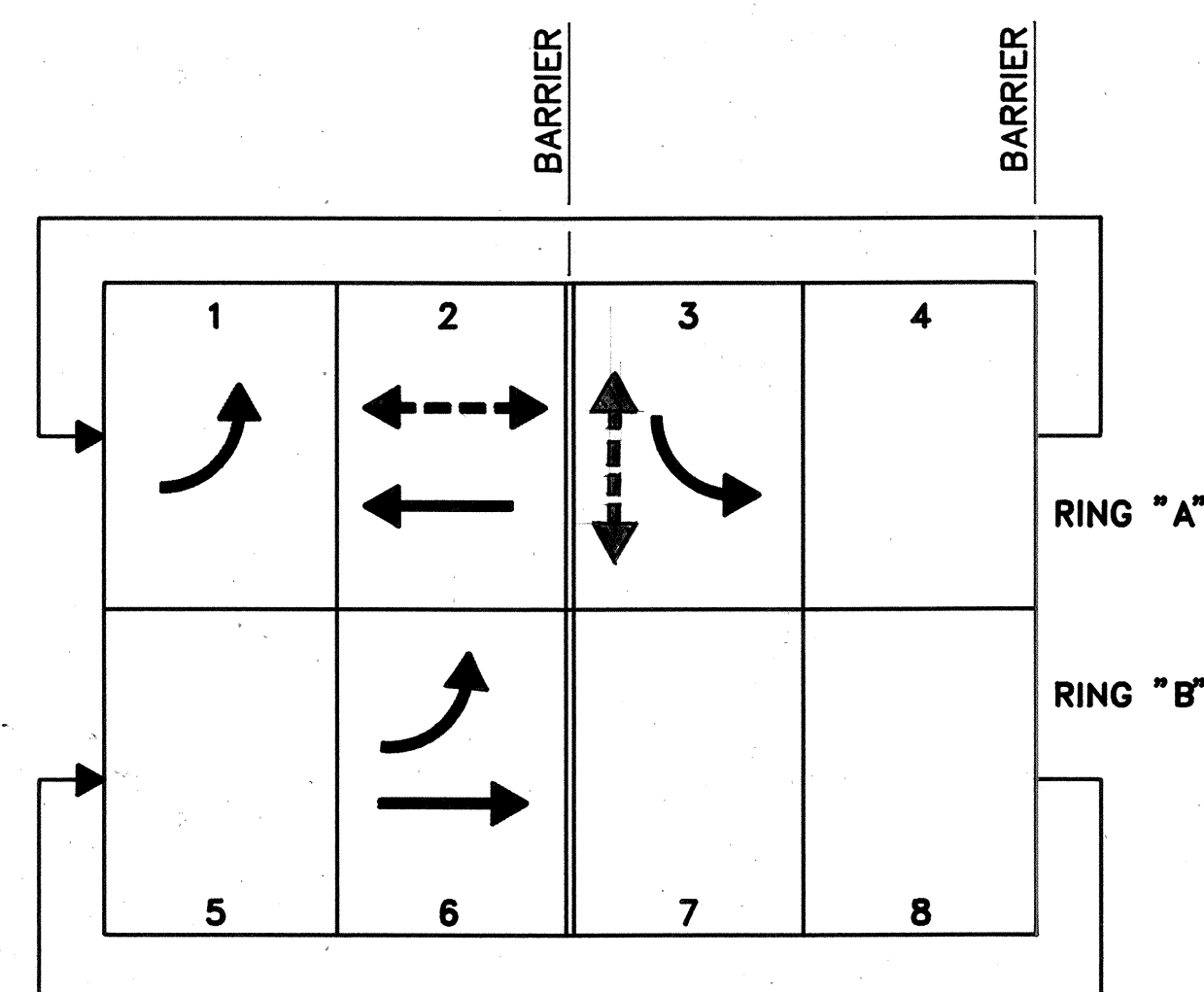

PHASE DIAGRAM

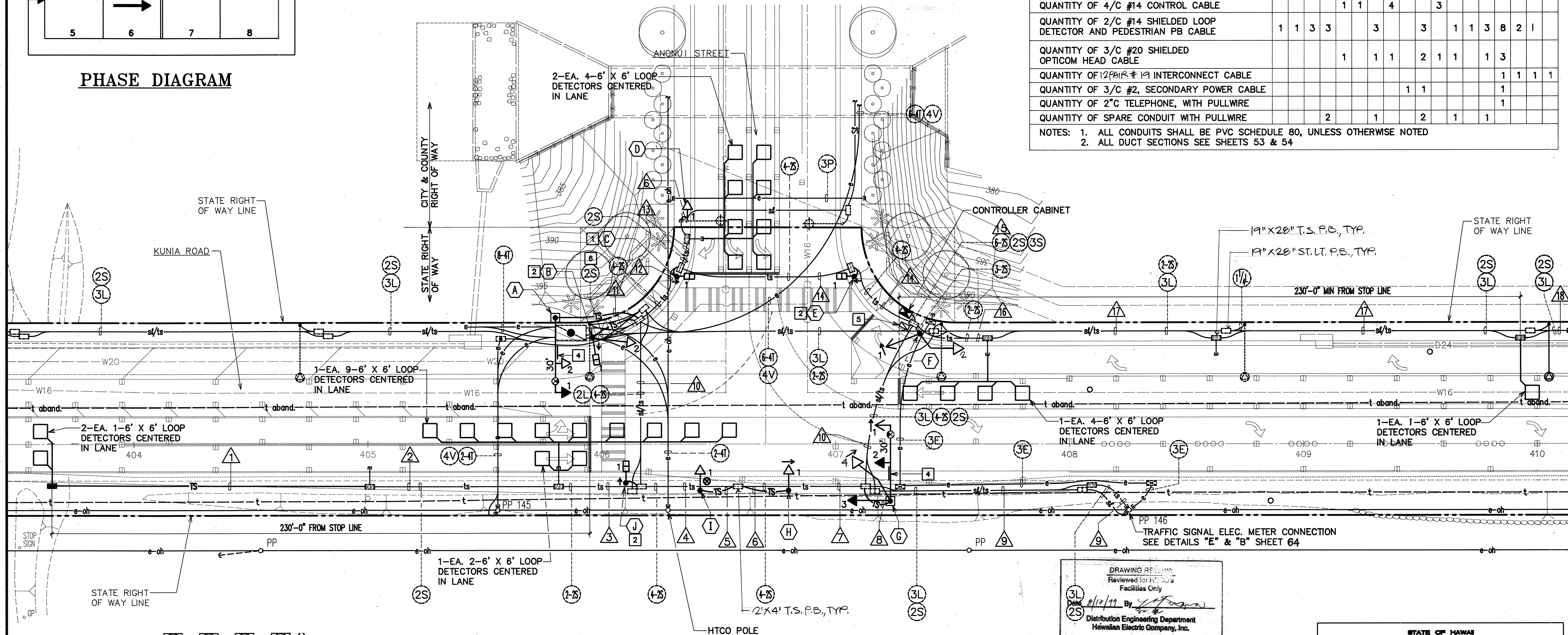

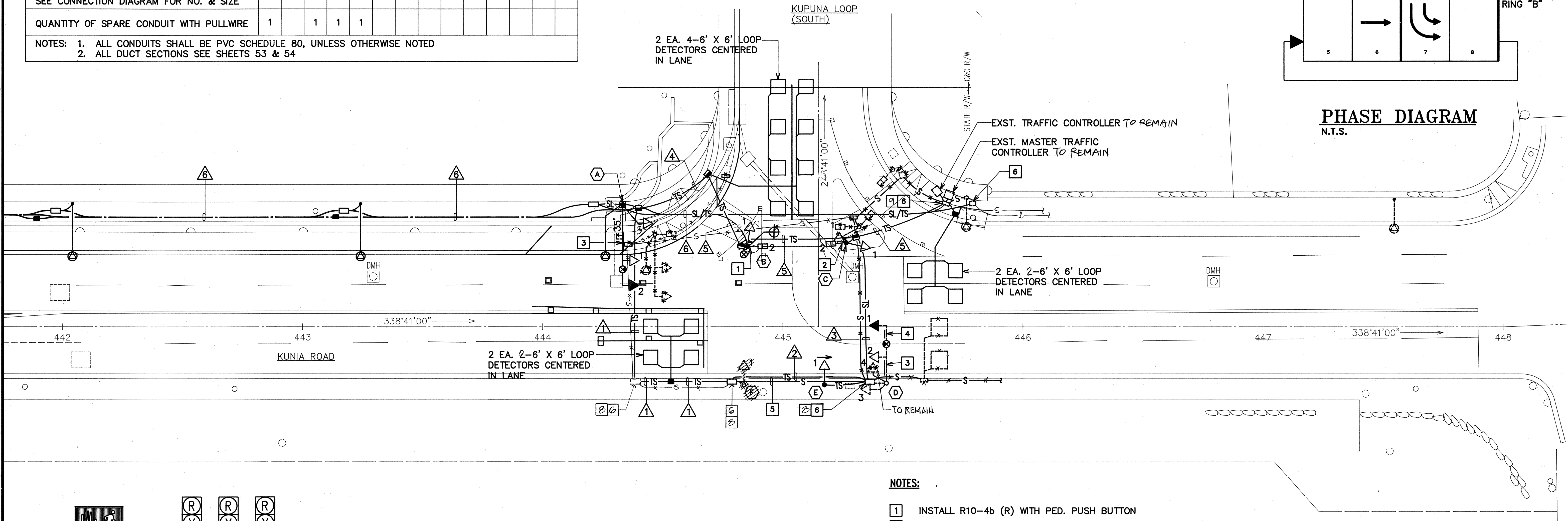

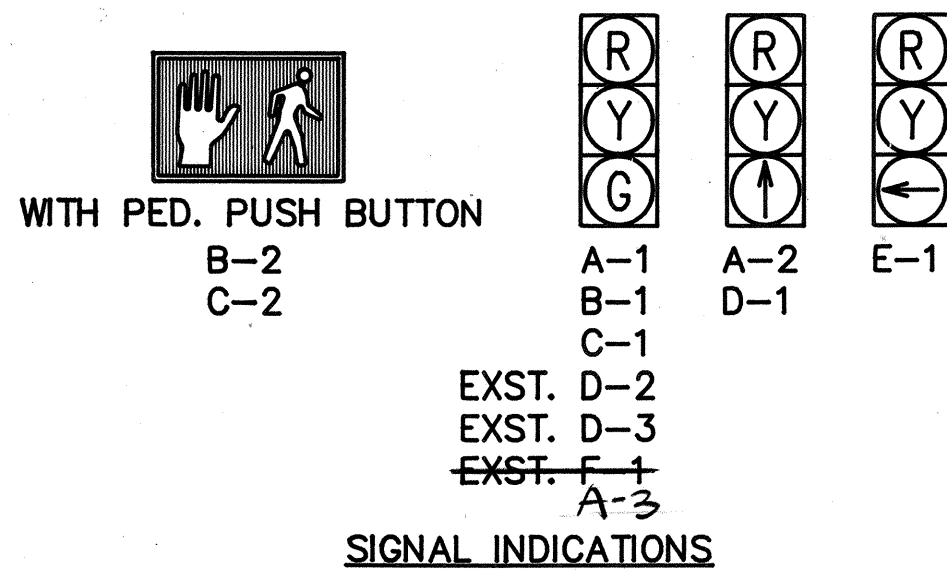


PHASE DIAGRAM

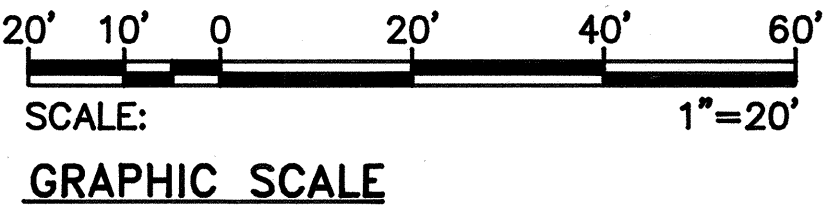

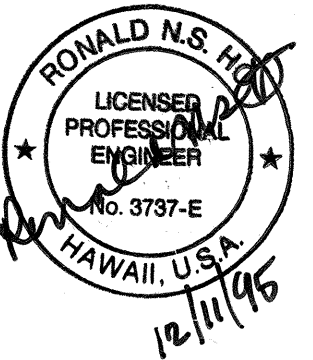
