The scope of work consists of cold planing, resurfacing, utility adjustment, widening, regrading, hydro-mulch seeding, and installation of guardrail, end treatments, grouted rubble paving, safety edge, shoulder dressing, pavement markings, striping, and signs. The estimated cost of construction is between \$2,000,000 and \$2,500,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering
"A" license at the time of bidding.

The Hawaii Products Preference pursuant to Section 103D-1002, Hawaii Revised Statutes (HRS), is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO-Form 38) to the DOT Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the DOT. A separate SPO-Form 38 shall

be completed and submitted for each product. Forms are available at http://spo.hawaii.gov/all-forms/.

A 5% bid adjustment for bidders that are parties to apprenticeship agreements pursuant to Section 103-55.6, Hawaii Revised Statutes (HRS), is applicable to this project.

Compliance with Act 192, SLH 2011 is a requirement for this project whereby a minimum of 80% of the bidder's work force on this project **must** consist of Hawaii residents.

A pre-bid conference is scheduled for <u>May 9, 2022, 10:00 am HST on Microsoft Teams</u>.

All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. **Due to the impacts of COVID 19, the pre-bid conference will be conducted virtually.**
