NOTICE TO BIDDERS (Chapter 103D, HRS)

The receiving of SEALED BIDS for WHITMORE AVENUE SIDEWALK IMPROVEMENTS, UAKANIKOO STREET TO IHIIHI AVENUE, Project No. 7012A-01-21, will begin as advertised on in HiePRO. Bidders are to register and submit bids through HiePRO only. See the following HiePRO link for important information on registering: <https://hiepro.hawaii.gov/welcome.html>.

Deadline to submit bids is – 2:00 P.M., December 16, 2021. Bids received after said due date and time shall not be considered.

The scope of work consists of constructing new concrete sidewalks on the north side of Whitmore Avenue from Uakanikoo Street to Ihiihi Avenue; and reconstructing curbs. The estimated cost of construction is between \$300,000 and \$500,000.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering "A" license at the time of bidding.

The Hawaii Products Preference pursuant to Section 103D-1002, Hawaii Revised Statutes (HRS), is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (Form SPO-038) to the Hawaii Department of Transportation (HDOT) Contracts office no later than 4:30 P.M., fourteen (14) calendar days prior to the bid opening date. Late submittals for this project will not be reviewed by the HDOT. A separate Form SPO-038 shall be completed and submitted for each product. A pre-bid conference is scheduled for 10:00 A.M., November 23, 2021. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not

mandatory. **Due to the impacts of COVID 19, the pre-bid meeting will be conducted virtually. Questions applicable to the Project Specifications should be submitted via HlePRO no later than two days prior to the scheduled date of the pre-bid meeting.**

ALL requests for information (RFI) shall be received in writing via HlePRO no less than 14 calendar days before bid opening. Questions received after the deadline will not be addressed. Verbal requests for information will not receive a response. Anything said at the conference is for clarification purposes and any changes to the bid documents will be made by addendum and posted in HlePRO.

Any protest of this solicitation shall be submitted in writing to the Director of Transportation, in accordance with §103D-701, HRS and §3-126, HAR.

Campaign contributions by State and County Contractors. Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by a legislative body.
