WITNESSETH: That for and in consideration of the payments hereinafter mentioned, the CONTRACTOR hereby covenants and agrees with the STATE to complete in place, furnish and pay for all labor and materials necessary for "FARRINGTON HIGHWAY LANDSCAPING, KAMEHAMEHA HIGHWAY TO FORT WEAVER ROAD, OAHU, PROJECT NO. 7101A-01-98", or such a part thereof as shall be required by the STATE, the total amount of which labor, material and construction shall be computed at the unit and/or lump sum prices set forth in the attached proposal schedule and shall be the sum of ______FOUR MILLION ONE HUNDRED THIRTY EIGHT THOUSAND AND NO/100 ___ DOLLARS

(<u>\$4,138,000.00</u>) as follows:

These documents, together with all alterations, amendments, additions and deductions thereto or therefrom, are attached hereto and/or incorporated herein by reference and made a part of this contract.

The CONTRACTOR hereby covenants and agrees to complete such construction within <u>FIVE HUNDRED</u> (500) working days from the date indicated in the notice to proceed from the STATE subject, however, to such extensions as may be provided for in writing under the specifications.
