  - a. Amy Yagi started meeting at 10:03 A.M., note the following:
    - 1. Meeting will be recorded.
    - 2. Anything said at the meeting was for clarification only. The bid documents shall govern over anything said in the meeting and discrepancies shall be clarified by addendum.
- 2. Questions about Project
  - a. Responded to Questions in HIePRO
    - Section 201 CLEARING AND GRUBBING 201.03(E)(I)

       Paragraph 2 adds the requirement to scarify to a minimum depth of 8 inches, moisture condition to at least 4 percent above the optimum moisture content, and compact to 90 percent relative compaction all subgrades and embankment areas. Paragraph 3 requires any area that develops shrinkage cracks (wider than 1/8-inch in width) be prepared again. How will the Department pay for the second preparation?

    - Specification Section 207.05, lines 36 and 37, states "The Engineer will not pay for clearing and grubbing in accordance with Section 201-Clearing and Grubbing." Please confirm that Clearing and Grubbing of Channel and Basin Excavation is incidental to the excavation items 207.1000 and 207.2000.

    - Specification Section 209 TEMPORARY WATER POLLUTION, DUST AND EROSION CONTROL paragraph 209.01(A) includes removing and disposing of hazardous wastes. Hazardous Waste disposal without definition is not quantifiable or priceable. This please confirm this work will be paid for in 209.0200 Additional Water Pollution, Dust and Erosion Control, Force Account.

    - 4. Specification Section 411.03(B)(3) specifies a deck finisher or slipform paver for the bus stop concrete paving. Both methods seem to be overkill for single lane short sections of concrete paving. Please modify specification to allow clary type screeds.

    - 5. Drawing C-3 (Sheet 4), Construction Notes 2, Access to Farm Lots, Note 3, requires a physical barrier be installed

after removal of earth berms to prevent unauthorized vehicles from accessing the farm lots. Please define physical barrier.

 Drawing C-5 (Sheet 6), Construction Notes – 4, Notes for Construction, Note 5, requires the Contractor to retain the services of a licensed professional Engineer(s) for quality control. Please provide a specification section to cover this work.

Drawing C-5 (Sheet 6), Construction Notes – 4, Notes for Construction, Note 8, requires the Contractor to be responsible for all overtime night work payments for City and County's, and States's staff and inspection personnel including consultants when the contract requires overtime or night work to be performed, or directs the Contractor to work additional shifts or overtime for City and County's or Contractor cannot convenience... a. responsible for overtime inspection fees when directed to work overtime or night work for the City and County's or State's convenience, as the cost is unquantifiable. This requirement should be removed. b. Contractor requires overtime and night shift staff and inspection rates (including transportation) for City and County, State and consultant personnel to prepare a responsive bid. Please provide via addendum.

- Drawings C-28 through C-31, Typical Sections, call out Biaxial Polypropylene Geogrid over Non-Woven Geotextile Fabric (716.02). Specification section 716.02 is for the Non-Woven Geotextile. Please provide a specification of the Biaxial Polypropylene Geogrid.

- 10.Bid Item 623.0039 (Proposal page P-25), Allowance HECo Service Charge for Traffic Signal Service is described as an allowance but pays 1 Lump Sum. Contractors need to know if it is an allowance or 1 Lump Sum. Please confirm if it is an allowance or lump sum item.

  - 2. Is it possible to extend the bid date at least 4 week?
    - -No, we are on a tight schedule and this project must be bid out by the end of June.
  - Is it possible to provide traffic control plans? Will full highway lane closure be allowed? Based on scope of work it is impossible to preform the work without full lane closure.
    - Traffic Control plans to be provided in the first addendum. We will not be using full lane closures. It was able to be done with both lanes of traffic open.
  - 4. If you have an RFI after May 20<sup>th</sup>, and it pertains to addendum 1, will you extend the date for questions? Or say you release the last addendum, but we have question on June 14<sup>th</sup>, can we ask question on it?
