Where Federal funds are involved, it is covenanted and agreed by and between the parties hereto that the sums of FOUR MILLION THREE HUNDRED SIXTY EIGHT THOUSAND EIGHT HUNDRED AND NO/100------DOLLARS (\$4,368,800.00) and TWO HUNDRED EIGHTEEN THOUSAND FOUR HUNDRED AND NO/100-----DOLLARS (\$218,400.00), portions of the contract price and extras, respectively, shall be paid out of the applicable Federal funds, and that this contract shall be construed to be an agreement to pay said sums to the CONTRACTOR only out of the aforesaid Federal funds if and when such Federal funds shall be received from the Federal Government, and that this contract shall not be construed to be a general agreement to pay said portions at all events out of any funds other than those which may be so received from the Federal Government; provided, that if the Federal share of the cost of the project is not immediately forthcoming from the Federal Government, the STATE may advance the CONTRACTOR the anticipated Federal reimbursement of the cost of the completed portions of the work from funds which have been appropriated by the STATE for its pro rata share.
