The State of Hawaii, Department of Transportation (HDOT), is requesting proposals for the INTERSTATE ROUTE H-1 PM CONTRAFLOW LANE, PHASE 2, VICINITY OF RADFORD DRIVE TO WAIAWA INTERCHANGE and the INTERSTATE ROUTE H-1 PEARL CITY AND WAIMALU VIADUCT IMPROVEMENTS, PHASE 1. This is a **Design-Build** project. To be eligible for award, proposers must possess a valid State of Hawaii General Engineering Contractor's "A" license at the time of award of the contract. Estimated project cost is over \$50,000,000.

A pre-proposal meeting will be held on <u>January 12, 2010, at 9:00 a.m.</u> at the Oahu District Office, 727 Kakoi Street, Honolulu, Hawaii. All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. Persons needing special accommodations at the

Scope of Work: PM Contraflow Lane, Phase 2: The project includes engineering design and construction services required to add one additional lane in the westbound direction during the PM peak period in the vicinity of Radford Drive to the Waiawa Interchange (approximately 6.1 miles). Work consists of, but is not limited to, design and construction of new pavements, drainage systems, traffic control systems, pavement markings, traffic signs, guardrails and highway lighting; installation of new barriers to isolate contraflow lanes; selective demolition and removal; installation of contraflow crossover lanes; relocating and/or installing utilities; temporary and permanent Best Management Practices (BMP); and permitting to complete the project in conformance with appropriate Federal, State, and local standards. Pearl City and Waimalu Viaduct Improvements: The project includes full depth concrete deck repair; restoring pavement marking; traffic control; and permitting to complete the project in conformance with appropriate Federal, State, and local standards.

**Award of Contract:** This project will be awarded in a two-step process. Attention is directed to Section III – Qualification Proposal and Section IV – Design and Price Proposal of the Technical Provisions.

Phase-I Submission of a Qualification Proposal. Ten (10) copies of the Qualification Proposals must be received at the DOT Contracts Office no later than 4:00 P.M., January 27, 2010. It is the proposer's responsibility to ensure that the Contracts Office receives the Qualification Proposal on time.

The HDOT's Review Committee ("Review Committee") will determine the top three proposers based on qualifications contained in the Qualification Proposal. Proposers will be notified of their results on or around February 8, 2010.

Phase-II The top three proposers shall submit proposals (design concept documents and price) to the Contracts Office no later than 4:00 p.m., May 10, 2010. Additionally, the HDOT may conduct interviews with each proposer to provide the proposer an opportunity to present their design concept and to answer any questions the HDOT may have.

The successful proposer selected in accordance with subsection IV. E of the Technical provisions will be awarded the Project.

Award of Contract. This phase is the completion of the design and construction of the Project.

Campaign contributions by State and County Contractors. Contractors are hereby notified of the applicability of Section 11-205.5, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by the legislative body.
