The project includes removing existing roadway, walls, barrier, parking areas, cooling towers, and incinerator; widening existing off-ramp and roadway; installing wall and barrier, curbing, sidewalk, signing, lighting, and pavement markings, drainage structures, and piping; constructing new cooling towers, piping and appurtenances; cold planing; resurfacing; relocating existing water, traffic signal, traffic light, and gas utilities; and landscaping.

Plans and specifications may be examined and borrowed at the appropriate above offices. Borrowed plans and specifications shall be returned in good condition within 30 calendar days after the bid opening date.

Bidder's notice of intention to bid must be received at said Contracts Office no later than 4:30 P.M., 10 calendar days prior to the bid opening date.
